- Articulation report (Nicole Diamond) Cal-GETC 1C approvals are released. GWC's COMM C1000 Public Speaking was approved and the Interpersonal Communication was denied. Of all of the community colleges, only six non public speaking courses were approved for 1C. The remaining Cal-GETC approvals will be released in April and May.

1. Noncredit math curriculum The Math Department presented the new program proposals for 8 new noncredit certificates (accumulation for 29 total items). The department recognizes Jennifer's generosity to exceed the natural limit for prefixes. The department asks CCI to consider all to be approved effective Fall 2025; to have all the items to be discussed on today's agenda. The curriculum was not created to stay in compliance with a particular policy. These are support courses. Students are in calculus cannot factor. Gary stated the development of the curriculum was all standardized, outside of the topical item in each catalog description, SLOs, course objectives, and content. They are identical – the same would go for the programs outside the actual objectives because they must be different. The course titles which are drop downs and the topic item in the description, they're identical, thus allowing for fairly smooth readings. The committee discussed consenting mirrored curriculum in general and consider portions that are mirrored, but these are not mirrored. It is surprised of the quantity of courses and certificates with the current timeframe. These courses are intended to help students enrolled in transferable math courses concurrently enroll in these support courses to practice fundamental skills – open entry/open exit. It was discussed whether the intent to have all come through at the same time for an effective term of fall 2025 was presented with the program proposals in the fall 2024 committee meeting. The understanding was to have one course come through first and the rest to follow as the committee has practiced with batch/mass approvals in the past.

Kristy informed the committee there is a new math placement that is based on math courses students have completed in high school and grade point average. EX: if a student completes trigonometry or pre-calculus, they will now be directly place into calculus, which was not the case before.

All disciplines work on their curriculum with equity in mind. The question now is does the policy change to allowing faculty to bring in more than three items on each agenda. Discussion item four, curriculum handbook, needs to be reevaluated.

The concerns include pushing through curriculum quickly and they had to come back again to be fixed, not fair to all disciplines that complied with CCI policies with three items per agenda, how to be fair and equal for all, and how would the committee determine "dire need" when all disciplines work on their curriculum for students' success.

The deadline for Fall has already passed. The general timeline is fall to fall and spring to the following year's fall. Matthew moved to add the 19 additional items. Nicole stated the concern of rushing curriculum because there's a need and nobody had the chance to review the additional new 19 courses. Gary asked to hold off on curriculum with the STAT prefix and review others that have higher priority if all will not be reviewed. Matthew motioned to consider all 29 today, Gary seconded. Motion approved and will be placed on consent at the next CCI meeting; Jeanette, Ruth, and Cristian abstained; Michael V. and Ashley opposed. All math curriculum will be reviewed in alpha-numerical order after the counseling courses.
