## **DEAC - Minutes, 3-24-'25**

### **1. Welcome**

The meeting started at 2:31 PM. Alex M. welcomed the members of the DEAC.

### **2. Minutes 3-10-'25**

Alana K. moved to approve. Motion to approve seconded by Jason Sheley. The minutes were approved without changes by the DEAC members.

### **3. Reports**

**Accessibility Project** – Sheryl H. reported by describing the process. The Accessibility Check is in its second stage. ORPIE selected participants. Only courses that are fully on-line, or that have an on-line component are involved. FT and PT faculty may be selected randomly. The District (Andreea Serban), or GWC (VPI Jen KG, or Alex M) will notify the participants. Participants selected last year will not be reselected for the present check.

Sheryl H. demonstrated some of the functions of Udoit. Distance Education may be offering more workshops on the use of Canvas Studio.

**Canvas Training** – Sheryl H. reported that Barbara Cooper finished the Mandatory District Training. More information is needed regarding compensation for participation in the training, and other dynamics (e.g., certification, recertification, training from other institutions, etc.).

**LER Project** – Sheryl H. shared news about the submission of a small grant to support faculty and others on the development of a cohort to address “badges” related to distance education.

**ACCJC** – Alex reported on the submission and edit stage that the ISER is in. Jen VPI has distributed the document to the campus. The document resides, also, on the ORPIE webpage.

**4. POCR** - Michelle V. reported that she finished the training and is now awaiting further talks with Jen VPI about a working model of what GWC will do to support quality distance education at GWC. Also, Michelle V. reported that accessibility is emphasized heavily, as is RSI.
