The Executive Student Council will review and discuss updates to the Ralph M. Brown Act and the impact on public meetings. Assembly Bill (AB) 2449 revises The Brown Act's requirements for public meeting by teleconference. The Governor's executive order AB 361, provided a statutory exception, allowing for the use of teleconferencing without all of the Brown Act's restrictions in specific circumstances related to public health and safety emergencies. The Governor announced that the COVID-19 State of Emergency will end on February 28, 2023. AB 2449 is an alternative option under limited circumstances and expires Jan. 1, 2026. Senate Bill (SB) 1100 is a new process that allows for the removal of disruptive individuals.
