3. Return to Campus Plans:
 - a. Feedback on documents from Chancellor. All is contingent on Covid conditions and county guidelines. Dates and documents are tentative.
 - b. Please see attached sheet for notes on return to campus discussion.
4. GWC Magazine Oversight Task Force:
 - a. Six recommendations from the Academic senate. Oversight committee formed. This committee has seen all article and paid advertising. Recommendations to magazine publisher include stop using GWC emails, stop using language to influence joining GWC team or his team. Disclaimer on magazine that sponsored content doesn't rep GWC. A concern that a magazine is not necessary and is there any data showing how many read it. We are in the third year of contract. Budgetary issue as it takes the lion's share of Promotions budget.

5. District Strategic Plan: In process now and feedback will be requested. Dr. Serban is writing with input from DCC.
6. General Election Timeline:
 - a. Voting ended today and people will be notified Monday.
 - b. Elections for next year-process will start soon.
7. Committee Updates (2 min each):
 - a. Tech: District flexibility plan moving forward and feedback wanted. Zoom being transitioned over to District. Training is 6/7.
 - b. District Consultation Council: COVID update
 - c. Board Policy: Students returning after probation, some think students shouldn't get to appeal decision. Students have due process, so could be problematic if wrote into a BOT policy.
 - d. Recruitment to Completion: Give support to students and be aware of adjustment period when all return to campus. Concerns of closed classrooms. These can affect class interactions.
 - e. Strategic Plan task force: Come up with rough draft by end of FY so it can be addressed by Fall 2021. Concern of strategic plan getting in line with resource allocation and program review. Should be based on Vision 2030 goals. It is a tri chair model.
