- 7. During discussion about "Beyond the Blueprint" Jessica mentioned that visitors are not required to be vaccinated. Many prospective students, parents, vendors come to campus, but nothing is in place (to our knowledge) regarding vaccination status of visitors.
 - a. From Pratik: We are moving forward with discussing contracts. Cleared4 is a software that we will use for individuals to upload vaccination documentation, request exemptions, and upload test results obtained from testing with different places than the vendor we will use. Biocept is the company we are looking at to perform weekly COVID testing. On the employee side, we will be using NextGen forms initially but the

goal is to use Cleared4 for both students and employees. Norlyn Capitulo noted that employees that have previously filled out this form will be asked to fill it again as we will be asking for proof of vaccination.
